IARC concluded that continuous filament glass fibres are not classifiable as to their carcinogenicity to humans (IARC classification Group 3), confirming that there is currently no evidence for the carcinogenicity of continuous filament glass fibres to humans (IARC Monograph Man-Made Vitreous Fibres Vol. 81, 2002). Fibres with diameters greater than 3 microns, which is the case for continuous filament glass fibre, do not reach the lower respiratory tract and, therefore have no possibility of causing serious pulmonary disease. On the other hand, glass fibres indeed can cause a purely mechanical irritation (itching) of the skin and eyes. This is not an allergic reaction.
